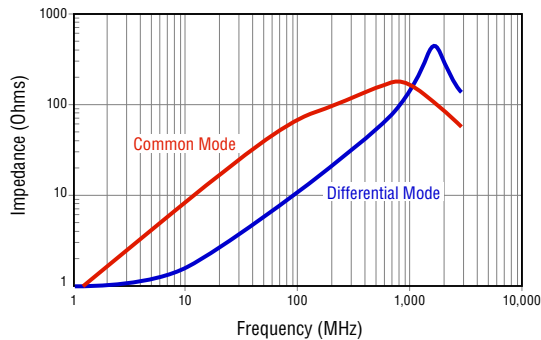

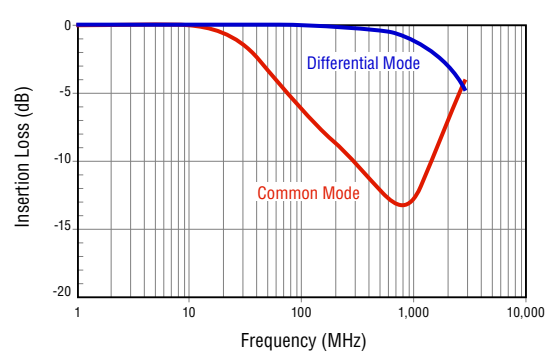

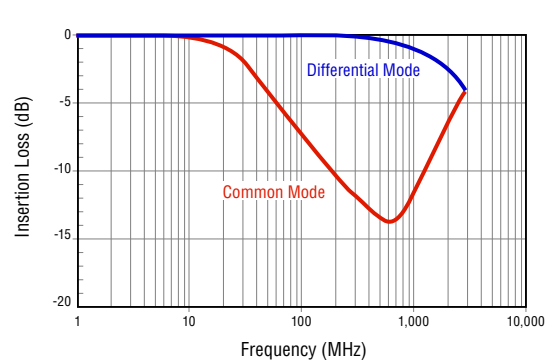


Typical Insertion Loss vs. Frequency Curves

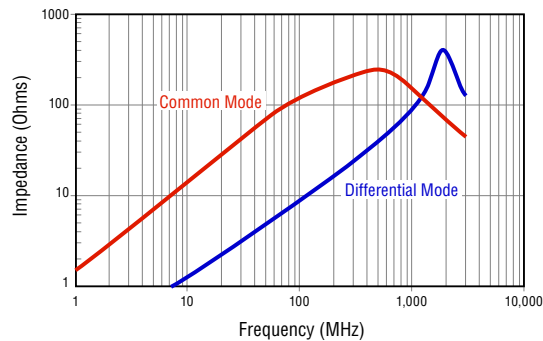

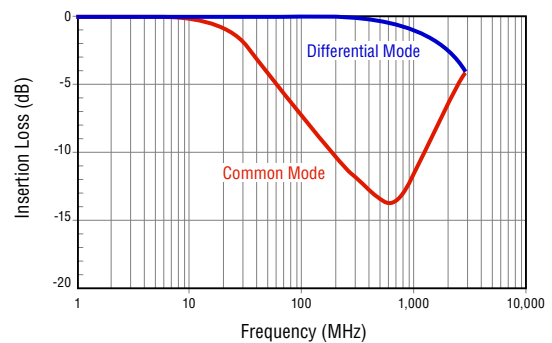
Typical Impedance vs. Frequency Curves – continued

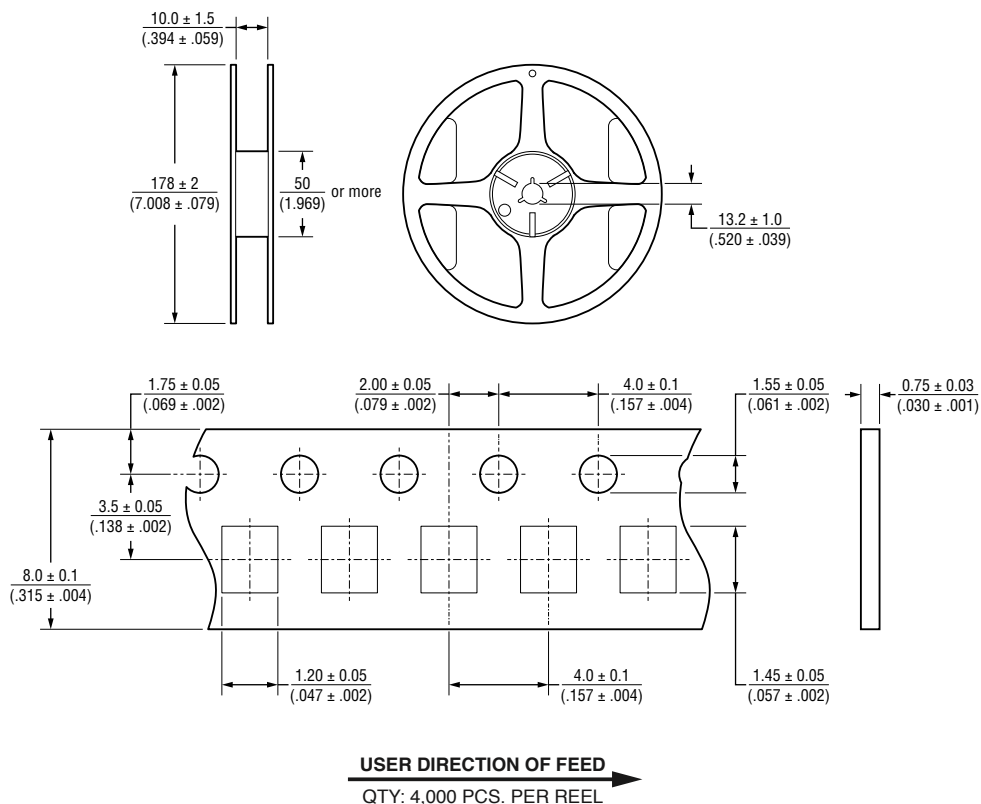


Typical Insertion Loss vs. Frequency Curves – continued
