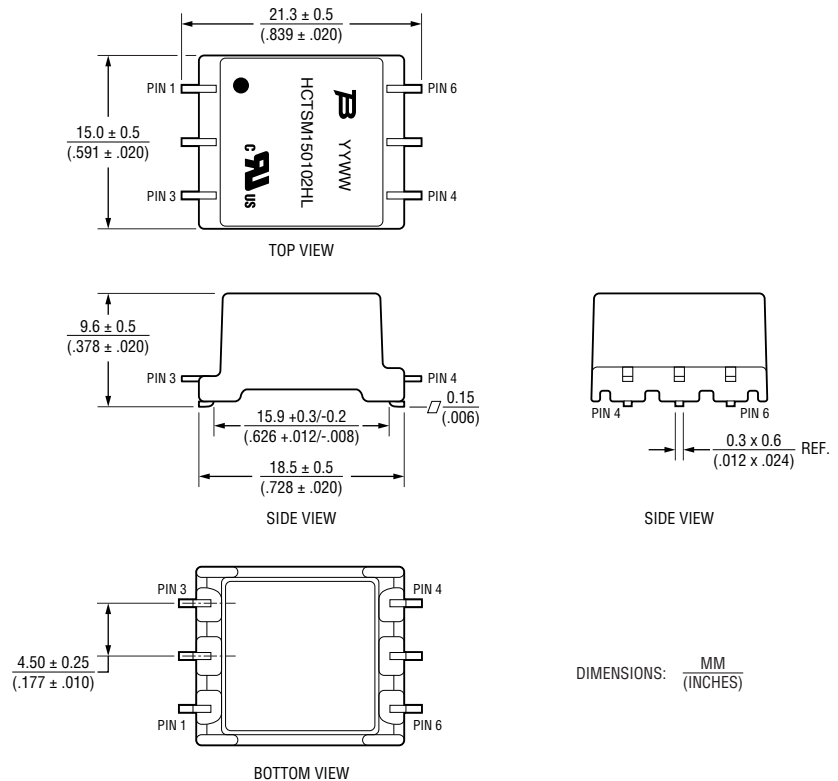

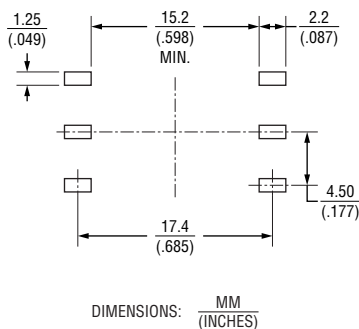

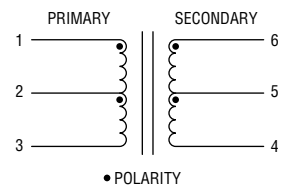

Electrical Schematic



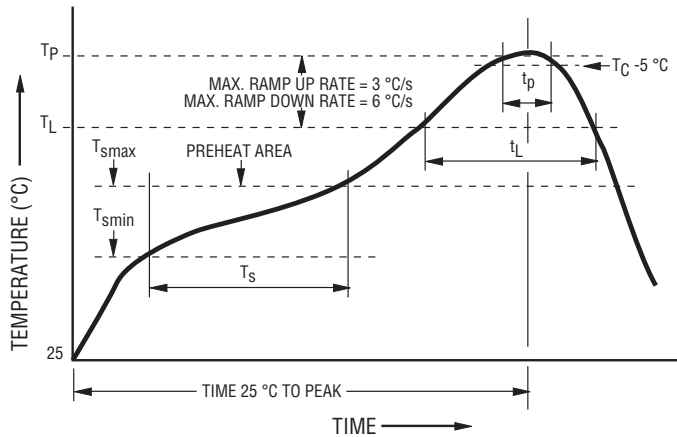

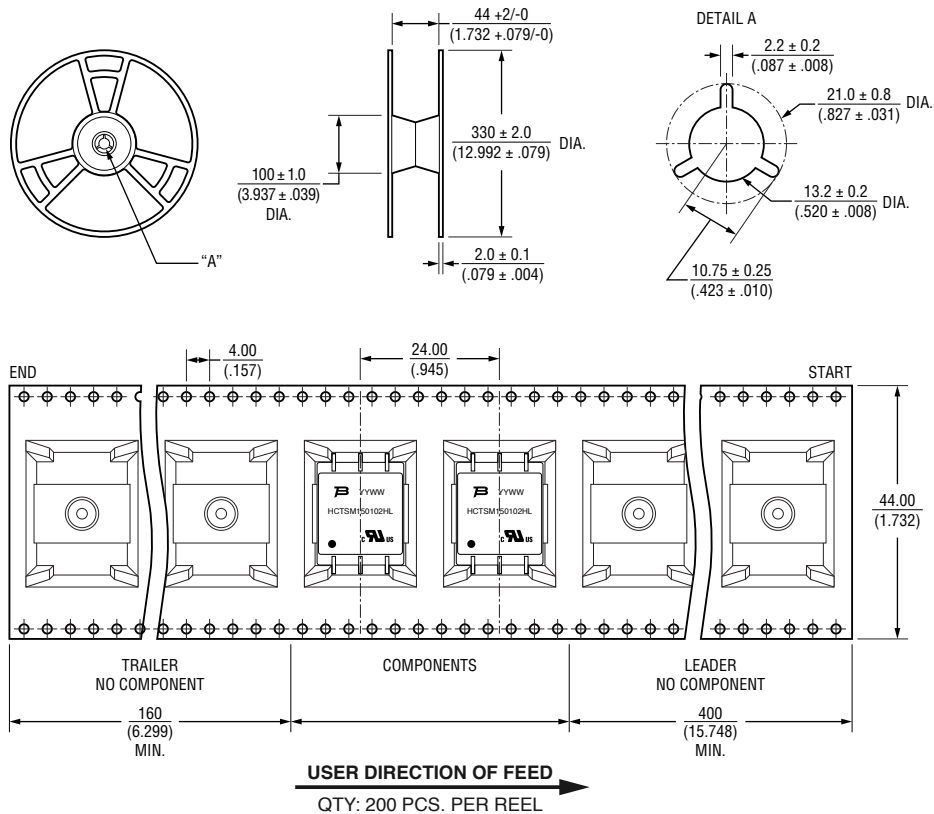
