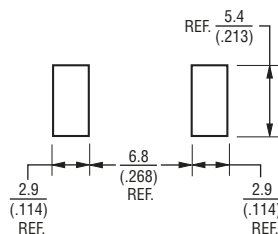

Recommended Layout



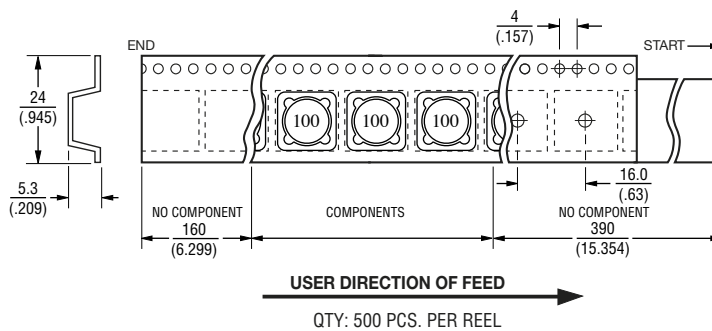
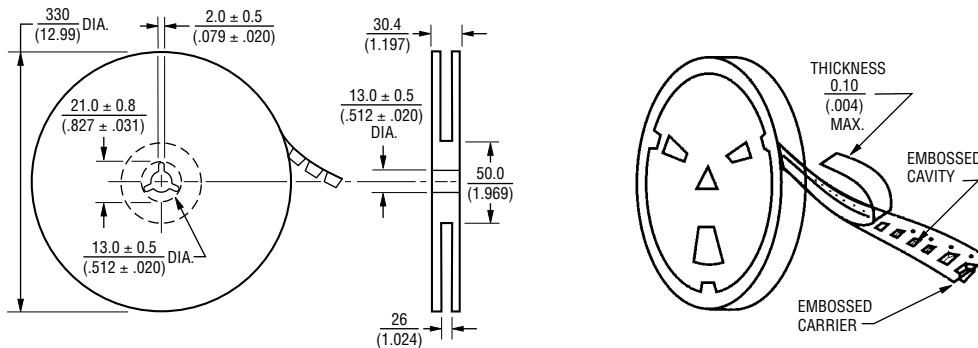
