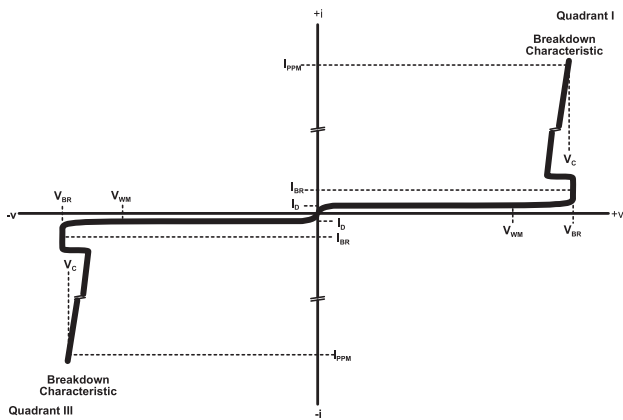

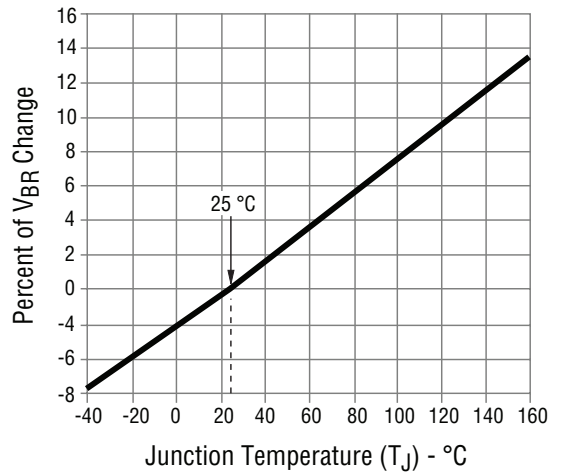

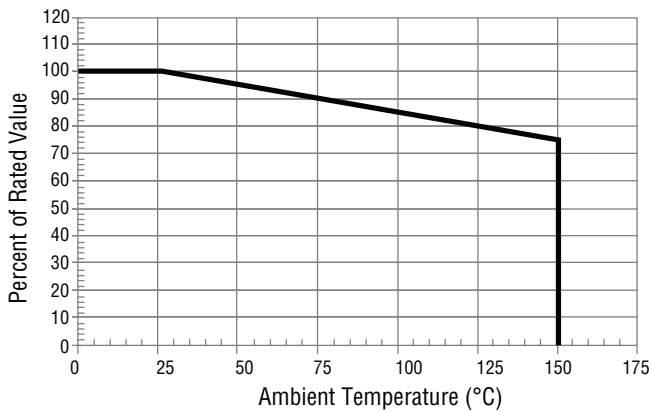
### V-I Characteristic



### Typical $V_{BR}$ vs. Junction Temperature

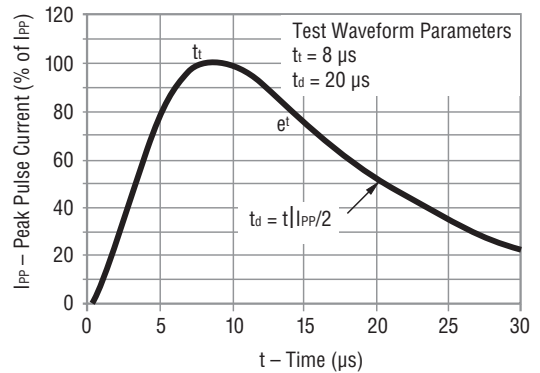


### Typical Surge Current Derating

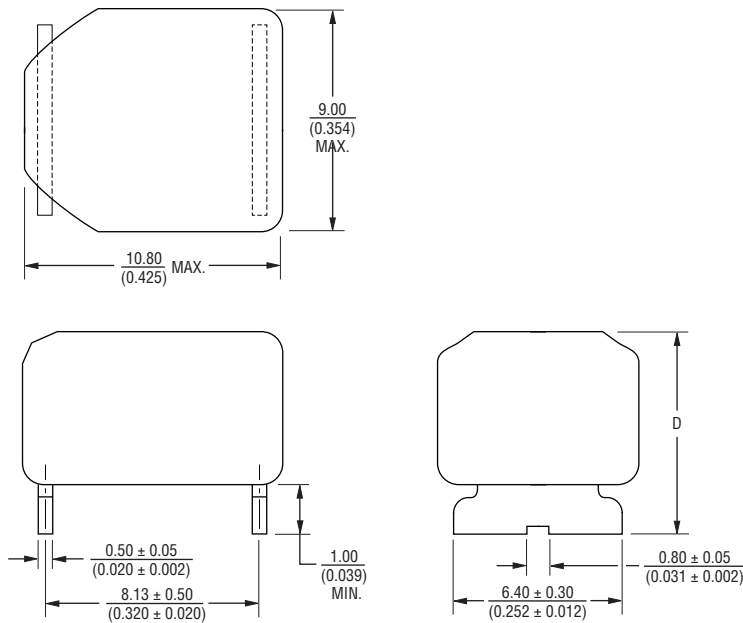

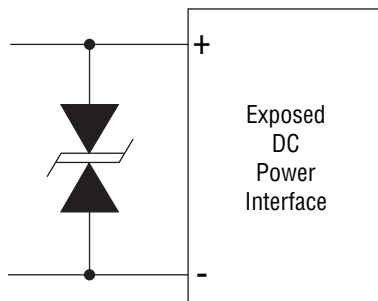

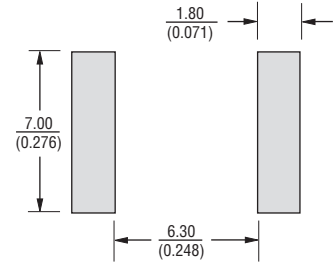

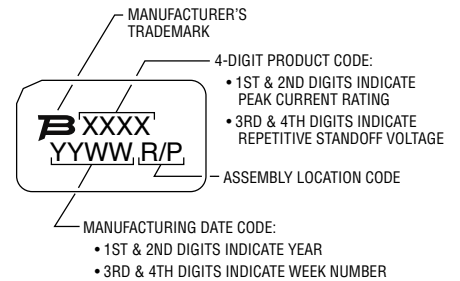

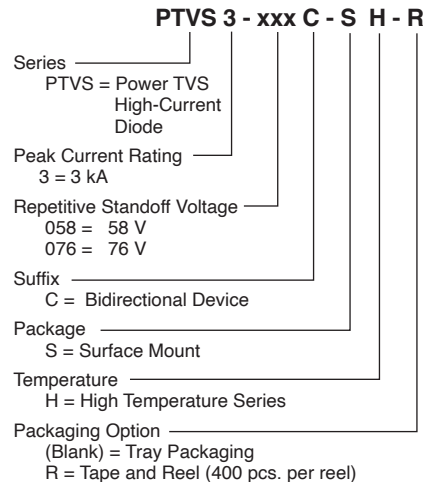
## Recommended Printed Wiring Land Pattern Dimensions
