### L vs. I Charts



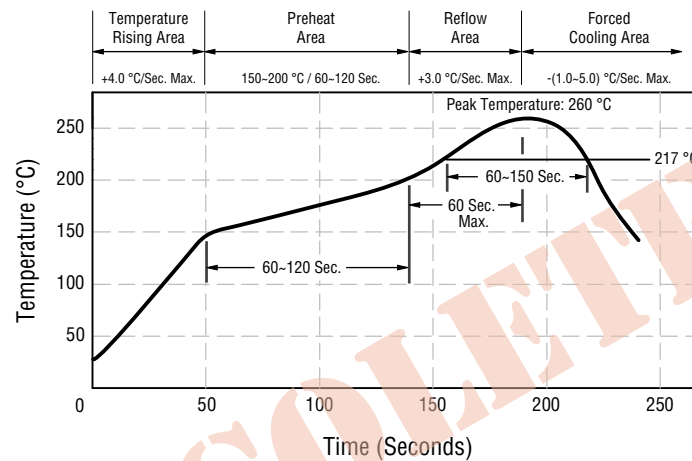
